A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE SECOND AMENDMENT
TO CONTRACT NO. C-17-343 WITH MERRIMAC PETROLEUM, INC. DBA
MERRIMAC ENERGY GROUP OF LONG BEACH FOR BULK AND CARDLOCK
FUEL SERVICES FOR CITY OWNED VEHICLES, AUTHORIZING AN EXPENDITURE
OF FUNDS NOT-TO-EXCEED \$100,000 [FOR A TOTAL EXPENDITURE OF FUNDS
OVER THE TERM OF THE CONTRACT NOT-TO-EXCEED \$1.9 MILLION]

WHEREAS, bulk and cardlock fueling services are necessary in delivering service to the residents of the City of Elk Grove (City); and

WHEREAS, in May of 2017, the City issued a formal Invitation to Bid (ITB) to seek economies of scale for bulk and cardlock fueling services for City-owned vehicles and thereby complied with the competitive bid requirements within the City's contracts and purchasing ordinance (Elk Grove Municipal Code Chapter 3.42); and

WHEREAS, Merrimac Petroleum, Inc. dba Merrimac Energy Group of Long Beach (Merrimac) met all the criteria in the ITB and was determined to be the lowest responsible and responsive bidder and Contract No.C-17-343 was issued; and

WHEREAS, Contract No. C-17-343 allows for amendments, changes, and extensions if those terms are agreeable to both parties; and

WHEREAS, in January 2020, Council awarded the first amendment to the Contract for an additional two years and \$300,000 in value; and

WHEREAS, with the unexpected surge in fuel costs, the City requires an additional \$100,000 in contract value; and

WHEREAS Merrimac has agreed to amend the existing contract at the current terms and conditions.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the second amendment to Contract No. C-17-343 with Merrimac Energy Group, in substantially the form presented, for bulk and cardlock fuel services for City vehicles, authorizing an expenditure of funds not-to-exceed \$100,000 [for a total expenditure of funds over the term of the contract not-to-exceed \$1.9 million].
