

**RESOLUTION NO. 2022-270**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO  
EGMC 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A  
PURCHASE ORDER WITH SURVEILLANCEGRID INTEGRATION INC. FOR THE  
PURCHASE OF THE BRIEFCAM VIDEO ANALYTICS TECHNOLOGY PLATFORM IN  
AN AMOUNT NOT TO EXCEED \$149,844.46**

**WHEREAS**, the City utilizes camera systems throughout the city of Elk Grove for various purposes such as traffic management, surveillance, investigations, apprehension of criminals, and locating missing persons; and

**WHEREAS**, searching video evidence is extremely time intensive and a video analytics platform will provide the Elk Grove Police Department (EGPD) with the ability to search video more efficiently and effectively; and

**WHEREAS**, staff at EGPD researched video analytics platforms extensively and recommends purchasing the BriefCam Video Analytics Platform due to its state of the art technology and analytics; and

**WHEREAS**, BriefCam provided staff with information on three integrating companies with the ability to integrate the BriefCam equipment at EGPD; and

**WHEREAS**, staff solicited informal quotes from the three companies and determined SurveillanceGRID Integration Inc. offers the lowest cost to the City for the integration of the BriefCam Video Analytics Platform; and

**WHEREAS**, for the reasons presented, undergoing a formal bidding procedure is not in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal bidding procedure pursuant to EGMC 3.42.180(B)(3) and authorizes the City Manager to execute a purchase order with SurveillanceGRID Integration Inc. for the purchase of the BriefCam Video Analytics Technology Platform in an amount not to exceed \$149,844.46.
