

**RESOLUTION NO. 2023-070**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE  
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH  
PYROSPECTACULARS NORTH, INC. FOR THE 2023 AND 2024 FIREWORKS SHOW AT  
THE SALUTE TO THE RED, WHITE AND BLUE  
IN AN AMOUNT NOT TO EXCEED \$56,000**

**WHEREAS**, the Salute to the Red, White and Blue requires a professional fireworks show and technicians; and

**WHEREAS**, the City's prior fireworks contract has expired; and

**WHEREAS**, staff solicited three informal quotes from vendors and PyroSpectaculars submitted the only responsive proposal. PyroSpectaculars has included a modest price increase of \$500 per year, from 2022 into 2023 and 2024, locking in a fair and reasonable price; and

**WHEREAS**, PyroSpectaculars North, Inc. offers a fully produced fireworks show with a local technician; and

**WHEREAS**, the City desires to enter into an agreement with PyroSpectaculars North, Inc. for a two-year agreement to produce the City's fireworks shows in 2023 and 2024; and

**WHEREAS**, pursuant to Elk Grove Municipal Code (EGMC) Section 3.42.140(B)(3), the City Council may dispense with the request for proposal procedure when, in the judgement of the City Council, compliance with the procedure is not in the best interest of the City; and

**WHEREAS**, for the reasons presented, the City Council finds that the pursuit of quotes for fireworks proposals is not in the best interest of the City.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to EGMC 3.42.140(B)(3) and authorizes the City Manager to execute an agreement with PyroSpectaculars North, Inc., in substantially the form presented, for the 2023 and 2024 fireworks shows at the Salute to the Red, White and Blue in an amount not to exceed \$56,000.
