

RESOLUTION NO. 2023-143

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE
PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42 AND AUTHORIZING
THE CITY MANAGER TO EXECUTE AMENDMENTS TO THE MASTER SERVICES
CONTRACTS WITH RANEY PLANNING & MANAGEMENT, INC. FOR ON-CALL
CURRENT PLANNING AND ENVIRONMENTAL SERVICES**

WHEREAS, staff has identified the need to have additional resources available to assist in the processing of private development projects; and

WHEREAS, Section 3.42.140(B) of the Elk Grove Municipal Code allows the City Council to dispense with the formal request for proposal procedure when it determines that this procedure is not in the best interest of the City; and

WHEREAS, Raney Planning & Management, Inc. has qualified for and been awarded contracts through the City's contracts and purchasing procedures based on their expertise and competitive rates; and

WHEREAS, Raney Planning & Management, Inc. has completed tasks to the satisfaction of the City related to current planning and environmental review services; and

WHEREAS, Raney Planning & Management, Inc, through prior work performed under their current contracts, has become familiar with the City's General Plan, Zoning Code and other land use regulation documents, and environmental review processes, which will allow them to perform future tasks efficiently; and

WHEREAS, work under the proposed master services contracts will be authorized through Task Orders, approved by the Development Services Director or designee, which include the scope of work, not-to-exceed cost for services, and a schedule for completion of the specified work; and

WHEREAS, for the reasons presented, further pursuit of a competitive proposal process for the services to be provided through the proposed contract amendments is not in the best interest of the City.


