**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A MASTER SERVICES
CONTRACT WITH WEST COAST ARBORISTS, INC.
FOR ON-CALL ARBORIST SERVICES**

WHEREAS, the City of Elk Grove (City) has made a commitment to preserve existing trees by establishing protections for trees designated as landmark trees, trees of local significance, secured trees, or trees in the public right-of-way; and

WHEREAS, staff utilizes the services of an on-call consultant providing a certified arborist to meet the provisions of Elk Grove Municipal Code Chapter 19.12 (Tree Preservation and Protection); and

WHEREAS, the City's current contract with Tree Associates, Inc. concluded on June 30, 2023, as Tree Associates ceased operations; and

WHEREAS, the City released a Request for Proposal to solicit proposals from qualified consultants on April 28, 2023, and the City received one responsive proposal from West Coast Arborists, Inc. by the May 19, 2023 response deadline; and

WHEREAS, through a review of the submitted proposal and follow-up interview, the City has determined that West Coast Arborists, Inc. is qualified to satisfy the City's need for on-call arborist services; and

WHEREAS, work under the proposed master services contract will be authorized through Task Orders, approved by the Development Services Director or designee, which shall include the scope of work and a schedule for completion of the specified work.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a master services contract, in substantially the form presented, with West Coast Arborists, Inc, for on-call arborist services.
