

**RESOLUTION NO. 2023-182**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO ELK  
GROVE MUNICIPAL CODE SECTION 3.42.180(B)(4) AND AUTHORIZING THE CITY  
MANAGER TO EXECUTE PURCHASE ORDERS WITH MOTOROLA SOLUTIONS  
FOR THE PURCHASE OF POLICE PORTABLE AND MOBILE RADIOS THROUGH A  
COOPERATIVE PURCHASING AGREEMENT FOR A TOTAL AMOUNT NOT TO  
EXCEED \$346,050**

**WHEREAS**, the Elk Grove Police Department is adding 23 new positions in FY 2023-24; and

**WHEREAS**, many of the positions being added at the Department require the use of both mobile and portable radios to safely perform the associated job duties in the community; and

**WHEREAS**, the Department does not currently have enough mobile and portable radios to accommodate the new positions and needs to purchase radios for the new positions along with replacement mobile radios for those that have exceeded their life expectancy; and

**WHEREAS**, the Department currently uses Motorola police mobile and portable radios and it extremely satisfied with the product and service offered by Motorola; and

**WHEREAS**, pursuant to Elk Grove Municipal Code Chapter 3.42, the City Council may dispense with the competitive bidding process when the purchase is processed through a cooperative purchasing agreement that is substantially consistent with the provisions of the City's purchasing procedures; and

**WHEREAS**, Sacramento County has secured competitive pricing for this commodity via Contract #WA00034181 through a competitive process similar to the City's purchasing processes, and the City of Elk Grove may take advantage of this pricing for the purchase with Motorola.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal bidding procedure pursuant to EGMC 3.42.180(B)(4) and 3.42.220 and authorizes the City Manager to execute purchase orders with Motorola Solutions for the purchase of police portable and mobile radios through a cooperative purchasing agreement for a total amount not to exceed \$346,050.


