**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO AMEND THE OFFICE OF STRATEGIC
PLANNING AND INNOVATION'S BUDGET TO APPROPRIATE CALIFORNIA
OFFICE OF TRAFFIC SAFETY GRANT FUNDS UP TO THE AMOUNT OF \$115,000**

WHEREAS, the California Office of Traffic Safety's (OTS) mission is to effectively and efficiently administer traffic safety grant funds to reduce traffic deaths, injuries, and economic loss; and

WHEREAS, OTS provides grant funding opportunities to local agencies that will support and advance the mission of OTS; and

WHEREAS, the Office of Strategic Planning and Innovation desires to expand its promotion of bicycle safety using evidence-based strategies; and

WHEREAS, the City has been awarded a grant from OTS in the amount of \$115,000, and the City Manager has executed the grant agreement pursuant to Resolution No. 2018-149; and

WHEREAS, the safety of Elk Grove residents is an important concern of the City Council.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to amend the Strategic Planning and Innovation Department's revenue and expense budget within the Strategic Planning Grants Fund (Fund 247) to equal the grant funds of \$115,000 received and expended each fiscal year until the total grant award has been received and expended.
