

RESOLUTION NO. 2024-053

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO ELK
GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY
MANAGER TO EXECUTE A PURCHASE CONTRACT WITH RING POWER
CORPORATION FOR THE PURCHASE OF A USED FORD F-550 WITH A TEREX
LT40 AERIAL BUCKET IN AN AMOUNT NOT-TO-EXCEED \$149,000**

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements and additional vehicles when necessary; and

WHEREAS, the City's Fleet division needs to purchase an aerial bucket truck for the Public Works Traffic Signal Technician position; and

WHEREAS, because of the long lead times to procure an aerial bucket truck, the City entered into a Rent Purchase Option (RPO) Agreement with Ring Power Corporation (Ring Power) in November of 2023; and

WHEREAS, the RPO applies the rental charges towards the purchase of the unit and Ring Power is honoring the RPO with the City; thus, the City is receiving a competitive price for the used equipment; and

WHEREAS, the expenditures of staff time and money to compile the necessary bid documents for a single vehicle and the long lead time to deliver the needed vehicle will not likely result in a better price or an outcome more advantageous to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby determines that formal competitive bidding is not in the best interest of the City for the subject vehicle and hereby dispenses with the formal bidding procedure pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3) for the purchase of the subject vehicle; and

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute a contract with Ring Power, in substantially the form presented, for the purchase of a used Ford F-550 with a TEREX aerial bucket in an amount not-to-exceed \$149,000.
