

 - SEPA (2014)








FIGURE 1-4: EXAMPLE OF POLICY CHAPTER ORGANIZATION

	Elk Grove has implemented regulations to manage waste and promote the reduction, reuse, and recycling of materials. These regulations minimize the use of natural resources and encourage the use of innovative materials and technologies.

	Policy CIF-1-1: Facilitate recycling, reduction in the amount of waste, and reuse of materials to reduce the amount of solid waste sent to landfill from Elk Grove.




Climate Action Plan

- Provides a process for subsequent qualifying development projects to tier from in their CEQA document to achieve GHG the reductions



Transportation Analysis Guidelines

- Implements General Plan policies relative to:
 - Evaluating the performance of the roadway system
 - Analyzing a project for potential impacts relative to Vehicle Miles Traveled (VMT)
 - Considering operations of pedestrians and bicyclists
