1. CALL TO ORDER/ROLL CALL:

5.1 Brown Act Training (City Clerk's Office)

1. Assistant City Clerk Brenda Haggard presented the Brown Act Training to the Youth Commissioners. This included explanation of what Brown Act is and how it works with the Youth Commission.

5.2 Nominate and Vote on Appointment of 2020-2021 Youth Commission Officers (Chair, Vice Chair, Secretary, Historian, Communications Officer)

1. Chair – Commissioners Agbe-Davies, Nair Sharma, and Enriquez expressed interest in the position of Chair.
Adam Davis motioned Mide Agbe-Davies be appointed to Chair; Kassi Parsons seconded the motion. The motion did not pass with a 5/5/0 vote.
Adeyinka Maddy motioned Selena Enriquez to be appointed as Chair, Prayer Noyogiere seconded the motion. The motion did not pass with a 4/6/0 vote.
Adeyinka Maddy motioned Shay Nair Sharma to be appointed as Chair, Kassi Parsons seconded the motion. The motion did not pass

with a 3/7/0 vote. As not knowing how to proceed, the Youth Commission Advisor suggested postponing the appointment to the next meeting after clarifying with the City Clerk.

2. Vice Chair – This position’s interest depended on the Chair outcome, so postponed this appointment to the next meeting as well.
3. Secretary – Commissioner Kassi Parsons expressed interest in the position of Secretary. Selena Enriquez motioned Kassi Parsons to be appointed as Secretary, Mide Agbe-Davies seconded the motion. The appointment passed with a 10/0/0 vote.
4. Historian – Commissioner Adeyinka Maddy expressed interest in the position of Historian. Prayer Noyogiere motioned Adeyinka Maddy to be appointed as Historian, Adam Davis seconded the motion. The appointment passed with a 10/0/0 vote.
5. Communications Officer – Commissioners Neyha Thandi and Prayer Noyogiere expressed interest in the position of Communications Officer. Shay Nair Sharma motioned for Prayer Noyogiere to be appointed as Communications Officer, Trinity Mosby seconded the motion. The appointment passed with a 6/4/0 vote.
