
Subject: Road Closure Moratorium for the Holiday-Reminder Notice

The holiday season is just around the corner, and the City of Elk Grove will institute a construction moratorium on selected City streets starting from 5:00 pm on Friday November 17, 2023, through January 2, 2024, in accordance with Section 7-8.06 of the Standard Construction Specifications. Unless specifically approved by the Public Works Director or his designee, all construction activities and house structure moves, occurring between the hours of 7:00 AM and 10:00 PM, that interfere with public traffic on specific City streets (see enclosed table and map) will be restricted. Construction activities and house structure moves pertaining to these specific streets shall be completed prior to the moratorium or postponed.

Emergency repairs will be allowed, as set forth in Section 7-8.06 of the Standard Construction Specifications. Please send emergency work notifications to pwpermits@elkgrovecity.org and contact Naweed Ataie, Public Works Inspector, regarding repairs within one hour of your start time at (916) 627-3422 and/or nataie@elkgrovecity.org.

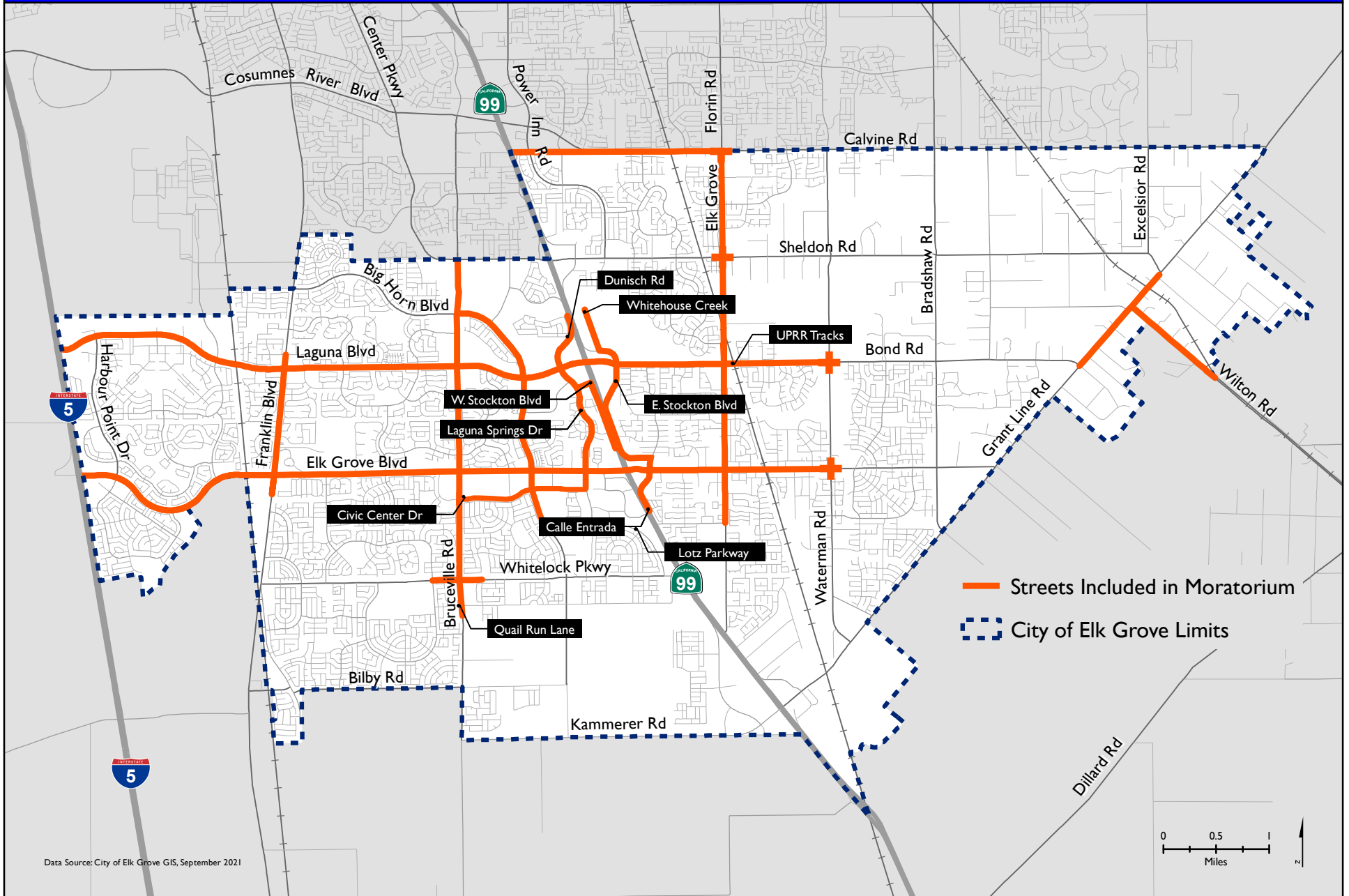

Laguna Boulevard	I-5 to Highway 99
Bond Road	Highway 99 to Waterman
Elk Grove Boulevard	I-5 to Waterman Road
Bruceville Road	Sheldon Road to Quail Run Lane
Big Horn Boulevard	Bruceville Road to Lotz Parkway
Civic Center Drive	Laguna Springs Drive to Bruceville Road
Laguna Springs Drive	Elk Grove Boulevard to Laguna Boulevard
Whitelock Parkway	Franklin High Road (west) to just past Walmart Shopping Center at corner of Bruceville and Whitelock (east)
West Stockton Boulevard	Dunisch Road to Elk Grove Boulevard and Laguna Springs Drive to Walmart cul-de-sac
East Stockton Boulevard	Whitehouse Creek to Calle Entrada
