### **FOULKS PARK CLEARWIRE WIRELESS COMMUNICATIONS FACILITY – CONDITIONAL USE PERMIT (EG-10-007)**

**REQUEST:** The project consists of a Conditional Use Permit (CUP) to construct and operate a wireless communications facility, which includes three panel antennas, three BTS units, and three parabolic antennas all mounted on a new 55-foot monopine tree pole. A 20 x 10 square foot lease area, with associated outdoor equipment, will be located adjacent to the pole's base and screened from public view by a six-foot chain link fence with green privacy slats.
