**NOTICE IS HEREBY GIVEN** that sealed bids will be opened and tabulated by or on behalf of the City Clerk at the City Clerk's designated office located at 8401 Laguna Palms Way, First Floor, Elk Grove, California, 95758 after **10:00 a.m.** local time on **Tuesday, September 10, 2019** for furnishing all labor, materials, tax, transportation, equipment and services necessary for the:

### **2020 PAVEMENT SLURRY SEAL AND RESURFACING PROJECT (WPR020) - PHASE I**

Any bids received after the time specified shall be returned unopened.

#### **Description of Work:**

The proposed work shall be performed in accordance with the plans, specifications and other contract documents and shall consist of the following: remove and replace asphalt concrete (AC) roadways, alleys, speed humps, and other related items as directed by the Engineer (Work).

The Opinion of Probable Cost (OPC) for the work is \$479,000.

In order to bid on or to be listed on the bid proposal for this Public Works Project all Contractors and subcontractors shall be registered with the Department of Industrial Relations and be qualified to perform Public Work pursuant to Section 1725.5 of the California Labor Code. Unregistered Contractors may still submit bids provided the bid is authorized by 7029.1 of the Business and Professions Code or by either section 10164 and 20103.5 of the Public Contract Code and Contractors register with the Department of Industrial Relations to perform Public Work pursuant to California Labor Code Section 1725.5 at the time the Contract is awarded. Subcontractors shall be registered prior to bid opening or within 24 hours of bid opening and paid the required penalty registration fees.
