A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
ELK GROVE REQUESTING THE SACRAMENTO
LOCAL AGENCY FORMATION COMMISSION TO
INITIATE PROCEEDINGS TO ANNEX TERRITORY WITHIN
THE CITY TO COUNTY SERVICE AREA NO. ONE

WHEREAS, the City of Elk Grove, California ("City"), was incorporated effective July 1, 2000; and

WHEREAS, by operation of Streets and Highways Code Section 25210.90, the territory within the City was excluded from the County of Sacramento's "County Service Area No. 1" ("CSA No. 1"), which provides funding for the maintenance of street lighting and safety lighting within Sacramento County; and

WHEREAS, condition 9.f. of Sacramento Local Agency Formation Commission Resolution No. LAFC 1207 the City's incorporation provided that the City initiate, before the end of its first full year of incorporation, a proposal to reorganize CSA No. 1; and

WHEREAS, the City Council wishes to ensure continued funding for street and safety lighting maintenance within the City.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED AS FOLLOWS:

1. The Mayor is hereby authorized to make application for the annexation of the territory described in the legal description attached hereto and marked as Exhibit "A" and shown on the map attached thereto and marked as Exhibit "B".

2. The Sacramento County Local Agency Formation Commission is hereby requested to initiate proceedings for the annexation of the territory as described in Exhibits "A" and "B" to CSA No. 1, in the manner provided by the Cortese-Knox Local Government Reorganization Act of 1985.



STAFF RECOMMENDATION TO COMMISSION (JUNE 2, 1999)
BOUNDARY FOR PROPOSED ELK GROVE INCORPORATION (S-96)

All that certain territory situate in the County of Sacramento, State of California, more particularly described as follows:

Beginning at the intersection of the centerline of California State Highway 99 and the Easterly projection of the centerline of Kammerer Road; thence, from said point of beginning, Westerly along said Easterly projection and centerline of Kammerer Road to the centerline of Bruceville Road; thence, Northerly along the centerline of Bruceville Road to the centerline of Bilby Road; thence, Westerly along the centerline of Bilby Road to the Westerly line of the Union Pacific Railroad; thence, Northerly along said Westerly line to the centerline of Dwight Road; thence, Easterly along the centerline of Dwight Road to the centerline of Franklin Boulevard; thence, Northerly along the centerline of Franklin Boulevard to the North line of the South one-half of the Southwest one-quarter of Section 21, Township 7 North, Range 5 East, M.D.B. & M.; thence, Easterly along said North line to the North-South center section line of said Section 21; thence, Southerly along said center section line to the South one-quarter corner of said Section 21; thence, Easterly along the South lines of Sections 21, 22, and 23 said Township and Range to the centerline of California State Highway 99; thence, Northwesterly along the centerline of said highway to the Westerly projection of the old centerline alignment of Calvine Road; thence, Easterly along said Westerly projection and centerline of Calvine Road to the centerline of Grant Line Road; thence, Southwesterly along the centerline of Grant Line Road to its intersection with the northwesterly projection of the northeasterly line of Spanish Grant Ranch Unit no.1 filed in the Sacramento County Recorder's Office in Book 91 of Maps, Map No. 17; thence, southeasterly along said projection to the most northerly corner of Lot 4 said subdivision; thence, South 49° 34' 07" East 1103.46 feet; thence, South 42° 24' 17" West 457.00 feet; thence, South 80° 14' 16" West 78.10 feet; thence, South 40° 25' 53" West 462.28 feet; thence, North 49° 34' 07" West 215.90 feet; thence, South 40° 25' 53" West 230.87 feet to a the northeasterly line of Parcel 3 as shown on the parcel map filed Book 30 of Parcel Map, at Page No 18, records of said county ; thence, southeasterly along said line and continuing southeasterly along the northeasterly line of Parcel 4 said parcel map to the most easterly corner of said Parcel 4; thence, southeasterly along the northeasterly line of Parcele 1 and 2 as shown on the parcel map filed in Book 128 of Parcel Maps, at Page No 25, records of said county, to the most westerly corner of Parcel C as shown on the parcel map filed in Book 6 of Parcel Maps, at Page No 28, records of said county; thence, northeasterly, southeasterly and southwesterly along the exterior boundary of said Parcel C to the most southerly corner thereof, said point being the most easterly corner of Parcel C as shown on the parcel map filed in Book 29 of Parcel Maps, at Page No 27, records of said county; thence, South 40° 30' 47" West 686.16 feet to the northeasterly line of Parcel A as shown on the parcel map filed in Book 24 of Parcel Maps at Page No. 40, records of said county; thence, South 49° 26' 45" East to the centerline of Dear Creek; thence, in a general southerly direction along said centerline to the southwesterly line of Lot 13 Central California Traction No. 13 filed in Book 13 of Maps, Map No. 33, records

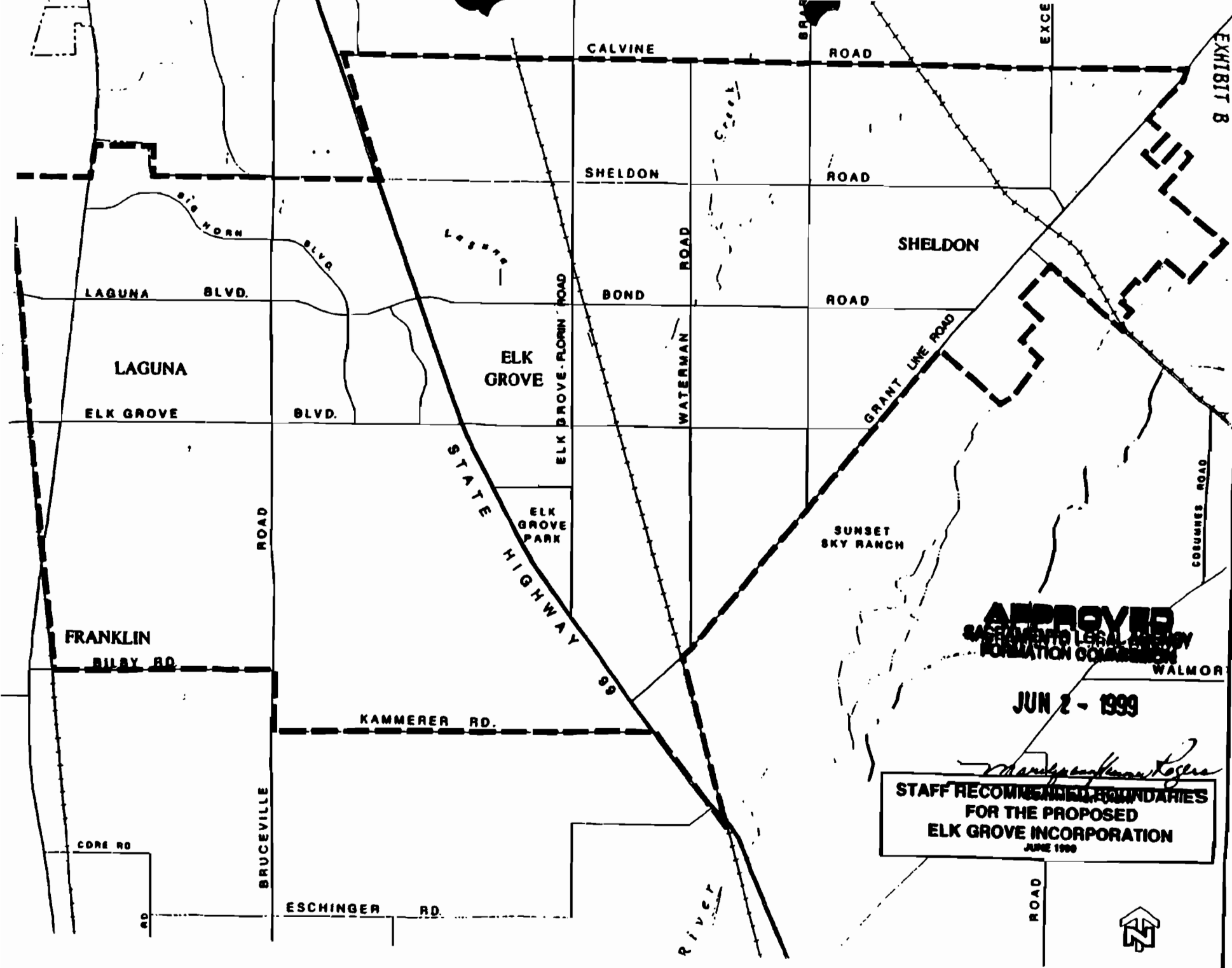
