A RESOLUTION OF APPLICATION PROPOSING PROCEEDINGS FOR ANNEXATION OF TERRITORY TO THE CITY OF ELK GROVE AS ANNEXATION NO. 03-01 LOCATED SOUTH OF THE SACRAMENTO CITY LIMITS, NORTH OF THE WETLAND PRESERVE, EAST OF INTERSTATE 5 AND WEST OF THE WESTERN ELK GROVE CITY LIMITS

WHEREAS, the City of Elk Grove desires to propose a change of organization, to wit, the annexation to the City of Elk Grove of the hereinafter-described territory, pursuant to Section 56654 of the Government Code of the State of California: and

WHEREAS, the proposed annexation territory is consistent with paragraph 9(e) of LAFCO Resolution No. 1207 making determinations for the approval of the incorporation of the City of Elk Grove and recommending submission of an application proposing a Sphere of Influence which incorporates the territory proposed for annexation: and

WHEREAS, on August 15, 2001, the City of Elk Grove submitted an application to the Local Agency Formation Commission proposing a Sphere of Influence;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Elk Grove that it hereby finds and determines as follows:

- 1. That the City of Elk Grove hereby proposes the annexation to the City of Elk Grove of the territory in Exhibit "A" and shown on the map marked Exhibit "B" attached hereto and made a part of this resolution as though fully set forth herein, located south of the city limits of the City of Sacramento, north of the wetland preserve, east of interstate 5 and west of the western city limits.
- 2. That a plan for providing services within the affected territory of the proposed annexation, in accordance with the provisions of Section 56653 of the Government Code, is marked as Exhibit "C", attached hereto and made a part hereof as though fully set forth herein.
- 3. That this proposal for change of organization, to wit, annexation is made pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, and it is requested that proceedings be authorized for annexation in accordance herewith.
- 4. That the territory proposed for annexation as described herein has been determined to be inhabited pursuant to Section 56046 of the Government Code.

- 5. That the territory proposed for annexation as described herein is within the boundary of the proposed Sphere Of Influence Amendment submitted to LAFCO on August 15, 2001.
- 6. That the names of the officers of the City of Elk Grove who are to be furnished with copies of the Executive Officer's Report and who are to be given mailed Notice of Hearing, if any, are:
