A RESOLUTION OF THE CITY OF ELK GROVE CITY COUNCIL VACATING A PUBLIC UTILITY EASEMENT LOCATED AT EMERALD VISTA DRIVE AND EAST STOCKTON BOULEVARD PURSUANT TO THE PROVISION OF THE PUBLIC STREETS, HIGHWAYS AND SERVICE EASEMENT LAWS

WHEREAS, on February 7, 2001, the City Council adopted Resolution No. 2001-03, a resolution of intention to vacate a public utility easement, and ordered that the hearing on the proposed vacation be set for the7th day of March, 2001, at the Robert L. Trigg Education Center, 9510 Elk Grove – Florin Road, Elk Grove, California; and

WHEREAS, notice of the date, hour and place of hearing of the proposed vacation was published for at least two successive weeks prior to the hearing; and

WHEREAS, at least two weeks before the day set for the hearing, at least three notices of vacation were conspicuously posted along the easement, not more than 300 feet apart; and

WHEREAS, the hearing described above has been conducted, and this City Council, having heard and considered all oral, documentary and other evidence presented, hereby finds, determines and orders as follows:

BE IT RESOLVED by the City Council of City of Elk Grove, a political subdivision of the State of California, that this City Council hereby finds as follows:

- a. That vacation of the public utility easement would be consistent with, and not violative of, the General Plan and all elements and components thereof for the City of Elk Grove;
- b. That the public utility easement is not useful as a non-motorized transportation facility because the dedication did not provide for that use;
- c. That the public utility easement is unnecessary for present or prospective public use because the existing water line has been relocated, and the letters from all the utility companies state that they have no use for the easement;
- d. The public interest will be served by the herein identified vacation.

BE IT FURTHER RESOLVED AND ORDERED THAT THE public utility easement described in the attached Exhibit A is hereby vacated.

BE IT FINALLY RESOLVED AND ORDERED that the Clerk of the Elk Grove City Council shall cause a certified copy of this Resolution of Vacation, attested by the Clerk under seal, to be recorded in the office of the Recorder of the County of Sacramento.
