

**RESOLUTION NO. 2024-096**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF  
UNDERSTANDING WITH THE COUNTY OF SACRAMENTO FOR ACCESS TO THE  
COUNTY'S WEBGIS DATABASES IN THE AMOUNT OF \$49,888.95 FOR A TERM  
OF TWO YEARS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE FUTURE  
RENEWALS IN AMOUNTS NOT TO EXCEED THE AMOUNT BUDGETED FOR THIS  
PURPOSE THROUGH THE ANNUAL BUDGET PROCESS, SUBJECT TO CITY  
COUNCIL APPROVAL**

**WHEREAS**, the City of Elk Grove (City) currently accesses the Sacramento County intranet and uses the County GIS viewers for specialized searches; and

**WHEREAS**, the City's ability to access property data instantly has proven to be efficient and time saving to staff; and

**WHEREAS**, the City has found the information provided by these services to be invaluable in the daily work of multiple departments; and

**WHEREAS**, the current agreement with the County for WebGIS access expires June 30, 2024, and a new agreement is entered into every two years.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Execute a Memorandum of Understanding with the County of Sacramento for access to the County's WebGIS Databases in the amount of \$49,888.95, for a term of two years; and
- 2) Execute all future agreements and related documents with the County of Sacramento for WebGIS access in amounts not to exceed the amount budgeted for this purpose through the annual budget process, which budget is subject to City Council approval.
