

## RESOLUTION NO. 2024-126

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIFTH AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF ELK GROVE AND THE CITY OF GALT FOR REIMBURSEMENT OF COSTS RELATED TO GALT RESIDENTS' USE OF THE CITY OF ELK GROVE'S SPECIAL WASTE COLLECTION CENTER AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL FUTURE AGREEMENTS, AMENDMENTS, AND RELATED DOCUMENTS WITH THE CITY OF GALT FOR USE OF THE SPECIAL WASTE COLLECTION CENTER**

**WHEREAS**, the Special Waste Collection Center (SWCC) provides household hazardous waste (HHW) collection services to residents of Elk Grove and the entire South Sacramento County region; and

**WHEREAS**, the City of Elk Grove (City) has partnered with several jurisdictions, allowing their residents to use the SWCC for HHW disposal; and

**WHEREAS**, on November 21, 2016, the City of Elk Grove and the City of Galt entered into an Agreement for Galt's participation at the SWCC (Contract No. C-16-588) and the parties subsequently entered into the First through Fourth Amendments to that agreement; and

**WHEREAS**, this regional concept is an important component of proper environmental stewardship in the Sacramento region as it provides easy and convenient method of HHW disposal for regional residents, thereby ensuring mitigation of environmental impacts of improper disposal; and

**WHEREAS**, the City of Elk Grove's agreement with the City of Galt for use of the SWCC is anticipated to be a continued long term arrangement with substantially consistent terms that are adjusted periodically for changes to costs, the applicable law, and SWCC operations; therefore, the City Manager shall have the authority to approve future agreements with the City of Galt, and any amendments thereto, for use of the SWCC.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

1. Execute the Fifth Amendment to the Agreement for Galt's Participation at the SWCC, Contract No. C-16-588; and

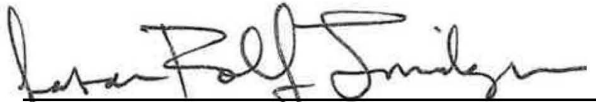
2. Execute all future agreements, amendments, and related documents with the City of Galt for use of the Special Waste Collection Center, all subject to approval as to form by the City Attorney, and provided that such agreements do not obligate the City of Elk Grove to pay expenditures that exceed budgeted amounts.


