## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FOR COMMUNITY CAT SPAY AND NEUTER RESOURCES FROM THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, DAVIS, CALIFORNIA FOR ALL ANIMALS GRANT PROGRAM AND AMEND ANIMAL SERVICES' BUDGET TO APPROPRIATE GRANT FUNDS IN THE AMOUNT OF \$125,000

**WHEREAS**, the Regents of the University of California, Davis (UCD), California for All Animals grant program provides grant funding for the purpose of increasing low-cost and free spay/neuter services; and

**WHEREAS**, UCD California for All Animals appropriated \$125,000 to the City of Elk Grove; and

**WHEREAS**, funds under this program must be used in accordance with Assembly Bill 132, Chapter 144, Statutes of 2021; and

**WHEREAS**, Elk Grove Animal Services desires to increase access to free spay/neuter services for community cats in accordance with the guidelines set forth in Assembly Bill 132.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept the awarded grant funding in the amount of \$125,000 from UCD California for All Animals for the purpose of increasing community cat spay and neuter services and resources in accordance with Assembly Bill 132; and
- 2) Take all action and execute all documents and/or agreements reasonably necessary to receive the grant funding, all subject to approval of any documents and/or agreements as to form by the City Attorney; and
- 3) Amend the Animal Services' revenue and expense budget, within the Local Police Grants Fund (Fund 217), equal to the amount received and expended each fiscal year until the total grant award has been received and expended.
