

RESOLUTION NO. 2024-131

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE FINANCE DIRECTOR TO SELL OR OTHERWISE
DISPOSE OF SURPLUS CITY PROPERTY IN THE FORM OF
CITY VEHICLES AND LAW ENFORCEMENT EQUIPMENT**

WHEREAS, the City of Elk Grove purchased vehicles to be utilized by various City Departments in the normal course of duties; and

WHEREAS, staff has designated 28 vehicles as surplus as they have reached the end of their service life based on years in service, high mileage, and/or frequency/cost of repairs, and collision damage; and

WHEREAS, any emergency response equipment shall be removed prior to any public sale; and

WHEREAS, Elk Grove Municipal Code Chapter 3.42 specifies the terms and conditions for the disposition of surplus City property; and

WHEREAS, the City of Elk Grove desires to surplus 28 vehicles and any associated emergency response equipment, and sell at fair market value or otherwise dispose of the assets.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the Finance Director to exercise the sale or disposal of surplus City property in the form of 28 vehicles, including the disposal of any associated emergency response equipment as shown in the attached Exhibit A, incorporated herein by reference, through sale to other law enforcement agencies, re-use by the City, donation, or designated as unsalvageable, based on the needs of the City; and

BE IT FURTHER RESOLVED that proceeds from any sale or disposal of the surplus vehicles shall be deposited into the Fleet Internal Services Fund and/or Risk Fund, respectively.
