

**RESOLUTION NO. 2024-148**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE TEN MASTER SERVICES CONTRACTS WITH BENNETT ENGINEERING SERVICES; R.E.Y. ENGINEERS; JACOBS ENGINEERING GROUP; TRANSYSTEMS; DOKKEN ENGINEERING; KIMLEY-HORN AND ASSOCIATES; PSOMAS; NJA ARCHITECTURE; LIONAKIS; AND CSG CONSULTANTS, FOR ON-CALL ARCHITECTURAL/ENGINEERING SERVICES FOR LOCALLY FUNDED CAPITAL PROJECTS WITH A TOTAL COMPENSATION AMOUNT FOR ALL TEN CONTRACTS OVER A FIVE-YEAR TERM NOT TO EXCEED \$22,000,000**

**WHEREAS**, the City of Elk Grove (City) uses on-call consultants to provide architectural/engineering services to deliver projects in the Capital Improvement Program (CIP); and

**WHEREAS**, the current on-call list will expire on November 13, 2024; and

**WHEREAS**, the City is seeking to create a new on-call list of ten pre-selected, pre-qualified architectural/engineering consultants for locally funded projects; and

**WHEREAS**, staff utilized a formal selection process in accordance with the City's Purchasing Ordinance and Policy, Caltrans' Local Assistance Procedures Manual, and state and federal laws, and prepared a Request for Qualifications (RFQ) for On-Call Architectural/Engineering Services; and

**WHEREAS**, the RFQ was advertised on May 9, 2024, and a total of 23 firms submitted proposals by the June 11, 2024 due date; and

**WHEREAS**, the RFQ requested separate statements of qualifications from each firm for locally funded projects and for state/federal funded projects; and

**WHEREAS**, Bennett Engineering Services; R.E.Y. Engineers; Jacobs Engineering Group; TranSystems; Dokken Engineering; Kimley-Horn and Associates; Psomas; NJA Architecture; Lionakis; and CSG Consultants were determined to be the most qualified firms to perform architectural/engineering services for the locally funded projects; and

**WHEREAS**, the City has negotiated Master Services Agreements with each of the named consultants to provide the required services.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute Master Services Agreements, in substantially the forms presented, for On-call Architectural/Engineering Services for locally funded CIP projects with the following consultants at the amounts shown:


