## **RESOLUTION NO. 2024-174**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH WILTON RANCHERIA REGARDING THE TREATMENT OF CULTURAL ITEMS AND THE TREATMENT AND DISPOSITION OF HUMAN REMAINS FOR THE KAMMERER RD TWO-LANE EXTENSION I-5 TO BRUCEVILLE ROAD PROJECT (WTR014) AND TO EXECUTE AMENDMENTS UP TO \$300,000 (NO FURTHER CEQA REVIEW REQUIRED)

**WHEREAS**, the proposed Kammerer Rd Two-Lane Extension I-5 to Bruceville Road Project (WTR014) ("Project") will construct a new two-lane extension of Kammerer Road from Interstate 5 (I-5) to Bruceville Road; and

**WHEREAS**, the land potentially has cultural significance to the Wilton Rancheria Tribe; and

**WHEREAS**, the Memorandum of Understanding is a precautionary measure in the event cultural items and/or human remains are discovered; and

**WHEREAS**, if no cultural items or human remains are discovered during Project activities, no further action is necessary; and

**WHEREAS**, if cultural items and/or human remains are discovered during Project activities, there will be costs associated with the handling of these items and/or human remains pursuant to the MOU; and

**WHEREAS**, the Project currently has sufficient budget included in the adopted Fiscal Year 2024-25 Budget and 2024-2029 Capital Improvement Program for environmental mitigation that would be used to cover any such costs and any necessary Project budget increases in future years are subject to City Council approval.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

1. Finds that the potential environmental impacts of the implementation of the Memorandum of Understanding were previously included and analyzed in the Project's Initial Study with Mitigated Negative Declaration (State Clearinghouse #2018022061). The Initial Study resulted in approval of a Mitigated Negative Declaration and adoption of a Mitigation, Monitoring, and Reporting Program (MMRP) on December 14, 2018. While the Connector JPA acted as the CEQA lead agency, the City is acting as the Responsible Agency for all portions of the Project.

No substantial changes are proposed to the Project as a result of the preparation and implementation of the Memorandum of Understanding and there are no substantial changes in circumstances or new information that would require revisions to the Project's MMRP or Initial Study with Mitigated Negative Declaration. Therefore, no further environmental review is required under CEQA; and

- Authorizes the City Manager to execute a Memorandum of Understanding with Wilton Rancheria, in substantially the form presented, regarding the treatment of cultural items and the treatment and reinterment of human remains that may be discovered as a result of the Kammerer Rd Two-Lane Extension I-5 to Bruceville Road Project (WTR014); and
- 3. Authorizes the City Manager to execute amendments to the Memorandum of Understanding in a total amount not to exceed \$300,000.
