

RESOLUTION NO. 2024-182

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING AMENDMENT NO. 5 TO THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) 2019-20 ACTION PLAN (CEQA EXEMPT)

WHEREAS, the Community Development Block Grant (CDBG) Program, authorized pursuant to Title 1 of the Housing and Community Development Act of 1974, as amended (Act), requires that jurisdictions provide for the issuance of grants in order to attain the objective of providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low- and moderate-income; and

WHEREAS, there has been presented to, and reviewed by this City Council, a 2013-2018 Consolidated Plan [extended by the U.S. Department of Housing and Urban Development (HUD) through June 2020], and a 2019-20 Action Plan; and

WHEREAS, in March 2020, the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed, and included \$5 billion of funding for the CDBG program to distribute to prevent, prepare for, and respond to the coronavirus; and

WHEREAS, \$2 billion of that funding was awarded by HUD to CDBG entitlement grantees according to the entitlement formula, resulting in an award of \$543,435 in CDBG-CV1 funding to the City; and

WHEREAS, on May 13, 2020, the City Council adopted Amendment No. 1 to allocate CDBG-CV1 funds; and

WHEREAS, an additional \$2 billion of CARES funding was awarded by HUD to CDBG entitlement grantees according to a formula that considered (1) risk of coronavirus transmission, (2) rate of coronavirus cases, and (3) economic and housing market disruptions related to the pandemic, resulting in an award of \$762,071 in CDBG-CV3 funding to the City; and

WHEREAS, on January 13, 2021, the City Council adopted Amendment No. 2 to allocate CDBG-CV3 funds; and

WHEREAS, on June 23, 2021, the City Council adopted Amendment No. 3 to reallocate unspent CDBG-CV funds to other CDBG-CV-eligible projects; and

WHEREAS, on January 11, 2023, the City Council adopted Amendment No. 4 to reallocate unspent CDBG-CV funds to other CDBG-CV-eligible projects; and

WHEREAS, subsequent to the adoption of Amendments No. 1, No. 2, No. 3, and No. 4 to the Action Plan, staff identified unspent funding available for reallocation to other CDBG-CV-eligible projects; and

WHEREAS, the amount of funding to be reallocated requires a substantial amendment to the Action Plan; and

WHEREAS, the City of Elk Grove has held, with proper notification and after a mandatory thirty-day public comment period, a public hearing on September 25, 2024, to receive comments and proposals from the public regarding the amendment to the Action Plan and use of CDBG-CV funds.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Elk Grove hereby finds the amendment to the 2019-20 Action Plan exempt from CEQA pursuant to the following finding:

Finding: The amendment to the 2019-20 Action Plan is exempt from the California Environmental Quality Act.

Evidence: The adoption of the amendment of the Action Plan is a project under CEQA; however, it qualifies for an exemption as follows:

1. The Public Service Program funded under the Action Plan is exempt from CEQA under CEQA Guidelines Section 15061(b)(3), which exempts activities under the common sense rule that CEQA only applies to projects that have the potential for causing a significant effect on the environment. The proposed programs provide services to the public within existing facilities. No new development or construction which would alter the built form of the community is proposed. Therefore, the Action Plan qualifies for this exemption and no further review is required for these programs.

AND, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby:

1. Approves the adoption of Amendment No. 5 to the City of Elk Grove CDBG 2019-20 Action Plan certifying that that the City of Elk Grove has and will continue to conduct its activities in accordance with applicable statutes and regulations governing the CDBG Program; and
2. Authorizes the City Manager, or authorized designee, to execute and file the amendment to the Action Plan, for and on behalf of the City of Elk Grove, and to make minor changes to the document where necessary.
