

RESOLUTION NO. 2024-187

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO ELK
GROVE MUNICIPAL CODE SECTION 3.42.180(B)(4) AND AUTHORIZING THE CITY
MANAGER TO EXECUTE TWO PURCHASE ORDERS FOR THE PURCHASE OF
OFFICE FURNITURE FROM MILES TREASTER ASSOCIATES THROUGH
COOPERATIVE PURCHASING AGREEMENTS FOR A TOTAL AMOUNT NOT TO
EXCEED \$272,136**

WHEREAS, the Elk Grove Police Department's Forensics and Property and Evidence Bureaus vacated spaces in 8380 and 8400 Laguna Palms Way buildings; and the vacated spaces are being repurposed and improved as part of the 8380 and 8400 Tenant Improvement Projects (WFC038 and WFC039) to maximize the space in both buildings to meet the Department's current and future needs; and

WHEREAS, both buildings will receive new furniture in many areas as part of the WFC038 and WFC039 Projects; and

WHEREAS, additional spaces in both buildings have been identified by staff that are in need of new furniture outside of the WFC038 and WFC039 Projects; and

WHEREAS, the Department currently uses Miles Treaster Associates (MTA) to furnish offices, as needed, and the City of Elk Grove (City) is using MTA to furnish spaces included in the WFC038 and WFC039 Projects; and


WHEREAS, pursuant to Elk Grove Municipal Code Section 3.42.180(B)(4), the City Council may dispense with the formal bidding procedure when the purchase of commodities and equipment is processed through a cooperative purchasing agreement that is substantially consistent with the provisions of the City's purchasing procedures; and

WHEREAS, OMNIA Partners has secured competitive pricing for this commodity through a competitive process substantially similar to the City's purchasing processes, and the City may take advantage of this pricing for the purchase with MTA; and

WHEREAS, funding is included in the adopted Fiscal Year 2024-25 Budget and 2024-2029 Capital Improvement Program to cover these purchase orders.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal bidding procedure pursuant to EGMC Sections 3.42.180(B)(4) and 3.42.220 and authorizes the City Manager to execute two purchase orders, in substantially the forms presented, with Miles Treaster Associates for the purchase of office furniture through cooperative purchasing agreements for a total amount not to exceed \$246,383.
