

**RESOLUTION NO. 2024-223**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON  
NOVEMBER 5, 2024, AND DECLARING THE RESULTS AND SUCH OTHER  
MATTERS AS PROVIDED BY LAW**

**WHEREAS**, a General Municipal Election was held and conducted in the City of Elk Grove, California, on Tuesday, November 5, 2024, as required by law; and

**WHEREAS**, notice of the election was given in the time, form and manner as provided by law; that candidates were nominated to fill the vacancy or vacancies as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects, the election was held and conducted and the ballots were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, pursuant to Council Resolution No. 2024-077 adopted May 22, 2024, the Sacramento County Registrar of Voters canvassed the returns of the election and has submitted the Certificate of Facts, attached and made a part hereof as Exhibit A.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ELK GROVE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**Section 1.** That the names of persons voted for at the election for Mayor are as follows:

**Mayor**

Brian Pastor  
Lynn Wheat  
Bobbie Singh-Allen

**Section 2.** That the names of persons voted for at the election for Members of the City Council are as follows:

**Council District 1**

Darren Suen

**Council District 3**

Kevin Spease

**Section 3.** That the number of votes given to each of the persons above named in Sections 1 and 2 for the respective offices for which the persons were candidates are displayed in Exhibit A, attached.

**Section 4.** That the City Council of the City of Elk Grove does declare and determine that:

- 1) Bobbie Singh-Allen was elected at-large in the City of Elk Grove as mayor for the full term of two years; and
- 2) Darren Suen was elected by-district in Council District 1 as a member of the City Council for the full term of four years. and
- 3) Kevin Spease was elected by-district in Council District 3 as a member of the City Council for the full term of four years.

**Section 5.** That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file in the Office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

**Section 6.** That the City Clerk shall enter on the records of the City Council of the City of Elk Grove a statement of the result of the election showing: 1) the whole number of ballots cast in the City of Elk Grove, 2) the names of the persons voted for, 3) for what office each person was voted for, and 4) the total number of votes given to each person.

**Section 7.** That the City Clerk shall certify to the passage and adoption of this resolution.


