

**RESOLUTION NO. 2024-230**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE MASTER SERVICES  
CONTRACTS WITH BENNETT ENGINEERING SERVICES; R.E.Y. ENGINEERS;  
JACOBS ENGINEERING GROUP; TRANSYSTEMS; DOKKEN ENGINEERING;  
KIMLEY-HORN AND ASSOCIATES; PSOMAS; AND TRC COMPANIES, FOR ON-  
CALL ARCHITECTURAL/ENGINEERING SERVICES WITH VARYING AMOUNTS NOT  
TO EXCEED \$5,000,000, FOR A TOTAL AMOUNT NOT TO EXCEED \$18,000,000**

**WHEREAS**, the City of Elk Grove (City) uses on-call consultants to provide architectural/engineering services to deliver projects in the Capital Improvement Program (CIP); and

**WHEREAS**, the City is seeking to create a new on-call list of eight pre-selected, pre-qualified architectural/engineering consultants for state/federal funded projects; and

**WHEREAS**, staff utilized a formal selection process in accordance with the City's Purchasing Ordinance and Policy, Caltrans' Local Assistance Procedures Manual, and state and federal laws, and prepared a Request for Qualifications (RFQ) for On-Call Architectural/Engineering Services; and

**WHEREAS**, the RFQ requested statements of qualifications for locally funded contracts and state/federal funded contracts; and

**WHEREAS**, the RFQ was advertised on May 9, 2024, and a total of 23 firms submitted proposals by the June 11, 2024 due date; and

**WHEREAS**, Bennett Engineering Services; R.E.Y. Engineers; Jacobs Engineering Group; TranSystems; Dokken Engineering; Kimley-Horn and Associates; Psomas; and TRC Companies were determined to be the most qualified firms for the state/federal funded contracts and the City has negotiated Master Services Agreements with these eight firms to provide the required services.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute Master Services Agreements for On-call Architectural/Engineering Services for state/federal funded capital projects, in substantially the forms presented, with the following firms in not to exceed amounts shown with an initial term of three years:


