- 3.2 Lana Yoshimura reported \$33.17 was spent on wristbands for the Blues event and additional event posters and postcards were ordered for \$170.80. With those expenditures, the Commission budget is currently \$22,142.88.

The Commission authorized \$600 from the event budget to be spent on a backline.

Mrs. Irons suggested future art projects including a mural on the pedestrian bridge over the 99 freeway near Wal-Mart, artwork for the roundabout near Oasis Park, and utility boxes. She will conduct some further research on these areas to assess feasibility.

Ms. Guttridge recently visited "A Seat at the Table" and suggested creating a monthly or quarterly art recognition program to highlight artists in the City.
