## 5.1 Staff update on the Elk Grove Register of Historic Resources

Senior Planner Killingsworth reported on the update for the Elk Grove Register of Historic Resources. The process is on a brief hold due to a staff change with the City's consultant. Staff is working on a new task order to have the same staff members work on the Elk Grove Register.

## 5.2 Staff update on recent and ongoing projects

Senior Planner Killingsworth provided a brief update on ongoing projects in the Old Town Special Planning Area. Most of the projects were Old Town Design Review Type 1, which are director levels for approval. It was reported that the property for 9029 Elk Grove Boulevard is up for sale.

## 5.3 Committee discussion on 2024 Goals

Co Chair Foseth-Andrews requested that the goals for the Committee in 2024 would include:

1. Complete the Local Registry by December 2024

2. For the committee to become a Commission. The Committee has requested that staff move forward with the process to become a Commission.

Senior Planner Killingsworth informed the Committee that at the next meeting, the Committee will review the CLG report, which is due April 26, 2024. Staff informed that the reporting is important to maintain the CLG status to be able to have the opportunity for future grants.

Staff provided two different months for a future council meeting; May or September. The reason for these choices: May is the Historic Preservation Month and September is usually History Week in Elk Grove. Co Chair Forseth- Andrews thought September will work and the Committee agreed. Co Chair Foseth-Andrews will attend the meeting in September to give the Council in update.
