6.1 Receive report on the Youth Needs Analysis project.

The Youth Needs Assessment survey received 447 responses, primarily from Harriet Eddy Middle School (189 responses), Franklin High School (96 responses), and Cosumnes Oaks High School (67 responses). Commissioner Rangwala presented the completed report draft, and Commissioner Akpo initiated further action based on the findings. The commission discussed reviving events that teach students proper time management skills, while the subcommittee emphasized the ongoing prevalence of mental health challenges as the most significant issue facing Elk Grove youth...
