a. Revised Section 2-8 "Subcontractors" percentage from 50% to 30% to match Boiler Plate Section B-8 "List of Subcontractors" and to conform to 23 CFR 635.116, the Caltrans Local Assistance Procedures Manual Chapter 16, and the Caltrans Construction Manual Section 3-507A.

Effect of Update:

1. This modification will remove the conflict between the Standard Construction Specifications and the project Boiler Plate Specification. The minimum of 30% of the work by the Prime contractor, can be increased if specified by the City.

2-8 SUBCONTRACTORS

Except as noted in the Special Provisions, the Contractor shall perform, with the Contractor's own organization and with workers under the Contractor's immediate supervision, work of a value not less than thirty percent (30%) of the value of original Total Contract Price less "Specialty Items" unless otherwise specified. "Specialty Items" may be performed by subcontract and the cost of any "Specialty Items" so performed may be deducted from the original Total Contract Price before computing the amount of work required to be performed by the Contractor. Where an entire item is subcontracted, the value of work subcontracted shall be based on the Contract item bid price. When a portion of an item is subcontracted, the value of work subcontracted from information submitted by the Contractor, subject to approval by the City. In accordance with the Subletting and Subcontracting Fair Practices Act, of the Public Contract Code, Section 4100 - 4114 et seq., each Bidder shall list in the bid form:

- The name and the location of the place of business of each Subcontractor whom the Bidder proposes to perform work or labor or render service to the prime Contractor in or about the construction of the Work, or a Subcontractor licensed by the State of California who, under subcontract to the prime Contractor, is proposed by the Bidder to specially fabricate and install a portion of the Work according to detailed drawings contained in the Contract, in an amount in excess of one-half of one percent (0.5%) of the Total Bid or, in the case of a Bid for the construction of streets or highways, including bridges, in excess of one-half of one percent (0.5%) of the Bidder's Total Bid or ten thousand dollars (\$10,000), whichever is greater.
- The portion of the Work [type of work and percentage if not one hundred percent (100%)] that shall be done by each Subcontractor. The Bidder shall list only one Subcontractor for each portion as is defined by the Bidder in the Bid.
