City of Elk Grove Amendment No. 5 to 2019-20 Action Plan

The following amendment language will be added to the 2019-20 Action Plan to allow the City to reallocated unspent Community Development Block Grant CARES Act Stimulus funding intended to prepare for, prevent, and/or or respond to the COVID-19 pandemic.

AP-05 Executive Summary

1. Introduction

On March 27, 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The Act identified additional funding for the Community Development Block Grant to prevent, prepare for, and respond to the community impacts of the COVID-19 pandemic. HUD's distribution plan for the additional funding included multiple phases that would allow for quick access to funding necessary to address the immediate crisis resulting from the rising pandemic, as well as phases that would support post-pandemic community recovery.

During the first phase, the City of Elk Grove received \$543,435 in Community Development Block Grant CARES Act Stimulus (CDBG-CV) funding. City Council approved amendments to the Community Development Block Grant (CDBG) Citizen Participation Plan, 2013-2018 Consolidated Plan (extended to June 2020) and 2019-20 Action Plan to allocate these funds on May 13, 2020. The second phase of distribution included \$1 billion of allocations to States and insular areas within 45 days of enactment of the Act. Elk Grove did not receive an allocation for phase two. The remaining \$2 billion in CDBG-CV funding was distributed to state and local governments according to a formula that considered public health needs, risk of transmission of coronavirus, number of coronavirus cases compared to the national average, and economic and housing market disruptions. In this third phase of distribution, Elk Grove received an additional \$762,071 in CDBG-CV funding. On January 13, 2021 Council approved amendments to the CDBG 2013-2018 Consolidated Plan (extended to June 2020) and 2019-20 Action Plan to reallocate these funds. On June 23, 2023 Council approved Amendment No. 3 to the 2019-20 Action Plan to reallocate \$610,917 in unspent funding. On January 11, 2023 Council approved Amendment No. 4 to reallocate \$170,000 in unspent funding.

This Action Plan amendment addresses the planning requirement for the reallocation of \$610,280 in funds from CDBG-CV projects that did not expend or are not anticipated to expend their full funding allocation. This reallocation will allow the City to make funding adjustments to reflect the community's current needs in the COVID-19 pandemic response.

2. Summary of the objectives and outcomes identified in the Plan

The priorities for the City's COVID-19 response are:

- Maintaining or improving access to public services; and
- Addressing and preventing homelessness.

These objectives were derived from continuing data showing that the COVID-19 continues to exacerbate existing needs. Public services, including nutrition support and housing assistance, particularly for

households suffering loss of income, and support for persons experiencing homelessness are key programmatic needs that have been identified in the CARES Act.

4. Summary of Citizen Participation Process and consultation process

The public comment period for this Action Plan amendment is thirty days, consistent with the City's Citizen Participation Plan. The public comment period exceeds the minimum of five days allowed by HUD's waiver.

The draft Action Plan amendment is available for comment from all interested parties from August 26, 2024, through September 25, 2024. A public hearing will be held on September 25, 2024 according to public participation requirements detailed in the Citizen Participation Plan.

5. Summary of public comments

1. Summary of citizen participation process/Efforts made to broaden citizen participation

Summarize citizen participation process and how it impacted goal-setting.

At the beginning of the COVID-19 pandemic, City staff surveyed essential services nonprofits that are funded through the City's Community Development Block Grant (CDBG) or Community Services Grant (CSG) programs. These nonprofits were identified as providing food or household supplies, monetary support, or significant social supports to vulnerable populations, including low-wage workers, senior citizens, and people experiencing homelessness.

Through continued outreach and discussion with nonprofit partners providing essential services, the City is able to assess community needs related to COVID-19 and identify funding priorities.

CV1 – The amended Citizen Participation Plan and the amendments to the 2013-2018 Consolidated Plan (extended through June 2020) and 2019-20 Action Plan were released for a 5-day public review period on May 8, 2020, with a public notice of availability published in the Elk Grove Citizen on May 6, 2020. A public hearing, with opportunity for public comment, was held during the May 13, 2020 City Council meeting.

CV3 – The amendments to the 2013-2018 Consolidated Plan (extended through June 2020) and 2019-20 Action Plan were released for a 13-day public review period on January 1, 2021, with a public notice of availability published in the Elk Grove Citizen on the same date. A public hearing, with opportunity for public comment, was held during the January 13, 2021 City Council meeting.

Amendment No. 3 Reallocation of unspent CDBG-CV — The third amendment to the 2019-20 Action Plan was released for a 12-day public review period on June 11, 2021, with a public notice of availability published in the Elk Grove Citizen on the same date. A public hearing, with opportunity for public comment, was held during the June 23, 2021 City Council meeting.

Amendment No. 4 Reallocation of unspent CDBG-CV – The fourth amendment to the 2019-20 Action Plan was released for a 19-day public review period on December 23, 2022, with a public notice of availability published in the Elk Grove Citizen on the same date. A public hearing, with opportunity for public comment, was held during the January 11, 2023 City Council meeting.

Amendment No. 5 Reallocation of unspent CDBG-CV - The fifth amendment to the 2019-20 Action Plan was release for a 30-day public review period on August 26, 2024, with a public notice of availability published in the Elk Grove Citizen on August 23, 2024. A public hearing, with opportunity for public comment, will be held during the September 25, 2024 City Council meeting. During the 30-day public review and comment period, the document will also be available for review at the following locations: Elk Grove City Hall, Elk Grove Public Library, Franklin Public Library, Senior Center of Elk Grove, and online at the Elk Grove City website (www.elkgrovecity.org). Copies of the draft amendment are made available upon request and are free of charge. If members of the public wish to provide testimony and are unable to participate in the public hearing meeting, written comments (or voicemails) that are delivered to the City Clerk's office prior to the time of the hearing will be made a part of the public record. The public comment period is concluded during a public hearing considering adoption of the draft amendment which is held before the City Council. During the public hearing, members of the public have the opportunity to present their comments prior to Council deliberation and action on the item. City Council Agenda packets are posted to the public, via the City's website and through a constant contact email list, by 2:00pm the Friday preceding the scheduled Wednesday Council Meeting. Agenda packets include online links to the draft amendment and corresponding staff report. City Council meetings are closed captioned and webcast on Sacramento Metropolitan Cable Television. Archived recordings of the meetings are posted on the City's website and rebroadcasted on metro cable channel 14. The City offers translation services for languages other than English and in compliance with the Americans with Disabilities Act makes reasonable arrangements to ensure accessibility to all public meeting. Public comment on all aspects of the City's CDBG programs is welcome and may be submitted by mail, email, or phone anytime of the year to the City's Housing and Public Services Manager or Senior Grant Analyst.

expects to undertake with 2019-2020 fiscal year funding including CDBG-CV allocations. This amendment is being proposed to reallocate approximately \$610,000 in unspent CDBG-CV funding from the US Department of Housing and Urban Development (HUD). This funding, approved federally as a part of the CARES Act, is intended to help jurisdictions prevent, prepare for, and respond to coronavirus. The City

plans to use these funds for shelter operations for residents experiencing homelessness. The release of this notice is one of the City's activities to fulfill citizen participation requirements.
